Subject: Constitution of committee for anti-ragging activities.

As made mandatory by the court of law and in order to ensure smooth academic atmosphere of the College a committee of the following officers/officials is hereby constituted to curb the ragging offense in the campus. The committee will strictly adhere to the directions of Honourable Supreme Court and take immediate actions against those who are found to be indulging in any form of ragging.

Further the punishment to be meted out to the persons indulged in ragging has to be exemplary and justifiably harsh so as to act as a deterrent against recurrence of such incidents. The students who are found to be indulged in ragging should be debarred from taking admission in any technical institution in India. Every single incident of ragging a First Information Report (FIR) must be filed without exception by the committee with the local police authorities.

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.

- i. Cancellation of admission
- ii. Suspension from attending classes
- iii. Withholding/withdrawing scholarship/fellowship and other benefits
- iv. Debarring from appearing in any test/examination or other evaluation process
- v. Withholding results
- vi. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- vii. Suspension/expulsion from the hostel
- viii. Rustication from the institution for period ranging from 1 to 4 semesters
- ix. Expulsion from the institution and consequent debarring from admission to any other institution.
- x. Fine of Rupees 25,000/-
- xi. Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
